

BIATHLON CANADA NATIONAL TEAM PROGRAM COMPETITION TOURS 2016 - 2017 Season

PREAMBLE

The National Team Program (NTP) of Biathlon Canada is the document that directs the High Performance aspects of Biathlon Canada's programs for the upcoming season. The foundation for this program evolves from the Biathlon Canada Mission and Vision Statements, the High Performance 2018 Plan, and the High Performance 2022 Plan.

The National Team Program in this document is set according to the 2016-17 IBU international calendar as of 30 June, 2016.

Changes to the IBU calendar, in regard to either dates or event venues, may necessitate changes to this Program. Biathlon Canada retains the right to alter the Program based on such changes.

GOALS FOR HIGH PERFORMANCE PROGRAM UNTIL 2022

- Multiple medal results at the Olympic Winter Games
- Podium performances at the WCH, WC, IBU Cup, and JWCH

OBJECTIVES FOR THE HIGH PERFORMANCE PROGRAM 2016-2017

- 1 x Top 3 performance at the World Championships
- 2 x Top 3 performances at World Cup races
- 1 x Top 3 performances at World Cup Relay races
- 1 x Top 3 performances at IBUC races
- 2 x Top-8 performance at Junior World Championships

PRINCIPLES DRIVING THE NATIONAL TEAM PROGRAM 2016-2017

 Biathlon Canada Long Term Athlete Development Model (LTADM) is a key guiding document to program success

GENERAL SELECTION METHOD

• Selection for World Cup (WC) and IBU Cup tours will be based on HPWG decision. These decisions will be guided by the following considerations:

GENERAL SELECTION PRINCIPLES:

- Selection results will be compared using performance percentages and final ranking.
 Performance percentage is determined by dividing the average of the top three finishers' final times by the final time of a particular athlete
- At selection events with one race, the performance percentage will be used for ranking
- At selection events with two races, two performance percentages will be averaged for ranking
- At selection events with three races, the best two-of-three performance percentages will be averaged for ranking
- Averages referred to above will be arithmetic-mean averages
- Only athletes who achieve an average performance percentage of 90% or greater against other athletes in their selection process (WC vs. WC, IBUC vs. IBUC, Juniors vs Juniors, Youth vs. Youth) will be eligible for selection
- Should a Pursuit competition be used for selection purposes, percentages will be calculated from athlete ski times, and not pursuit times
- A ski control (waxing) protocol will be used for all time trial and selection events unless announced no fewer than fourteen days in advance by the HPD

- Only Biathlon Canada registered participants in good standing will be eligible for selection
- Age and competency eligibility is as defined by the IBU Event and Competition Rules section 1.4 and any other documentation provided by the IBU
- Cases of incorrect calculation, omission, or process should be brought to the attention of the HPD immediately. If the selection remains in dispute appeal of selection is subject to the <u>Biathlon Canada Dispute Resolution and Appeals Policy</u>
- Athletes on tour are required to submit a signed 2016-17 Athlete Agreement no later than two weeks before the start of the tour
- Athletes paying tour fees are required to submit a signed 2016-17 Sanction Agreement no later than two weeks before the start of the Tour
- Athletes and staff on tour are required to conform to all relevant <u>Biathlon Canada Policies</u>, <u>Procedures</u>, and <u>Guidelines</u>

PRINCIPLES OF DISCRETIONARY SELECTION

Discretionary selections are employed to ensure selection of the most competitive team possible. Creating watertight, finite criteria for discretionary choices is impossible, since by their nature they are meant to account for unanticipated circumstances, which inevitably elude the principles of objective criteria. Based on the context of the situation, the HPWG will select the athlete(s) with the greatest likelihood of producing the best result based on the following factors:

- 1. History of performance in a specific competition format over the current and previous competitive seasons;
- 2. Recent improvements in results or performance parameters such as ski speed and shooting performance, both in training and competition;
- 3. Recent positive trend of competition results or performance parameters, such as ski speed and shooting, indicating potential for Olympic success. This includes indication of medal potential in future Olympic or World Championship competition that would be materially enhanced by selection to a team;
- 4. Recent decline in results or performance parameters such as ski speed and shooting performance (both in training and competition);
- 5. Performance/participation in the qualification process affected by illness or injury as certified by Biathlon Canada;
- 6. Ability to effectively contribute to a Relay Team;

If an athlete declines selection to any given Team, the HPWG will rely on the Principles of Discretionary Selection to fill the spot. The HPWG, in such circumstances, reserves the right to not fill the vacated position.

TOUR FEES

- Tour fees: No tour fees will be charged to athletes selected to World Cup tours, and athletes pre-selected to IBU Cup Tour 1.
- Athletes moved from a World Cup tour to an IBU Cup tour will not be charged a Tour fee; athletes moved from an IBU Cup tour to a World Cup Tour will not be charged any additional fee.

TEAM SIZE

• The HPWG retains the right to increase the team size for any given Tour or event in accordance with starts assigned by the IBU; in such circumstances, additional athletes will be selected according to the General Selection Method.

Selection: Male and female athletes will be selected in the following order of priority:

- 1. Greatest number of World Cup points earned in first trimester
- 2. Best single placing in a first trimester World Cup
- 3. General Selection Method for remaining positions
- 4. In the event that quota for WC #4 remains, up to two athletes per gender <u>MAY</u> be selected from IBU Cup Tour #1 based on the athletes' single best result. These athletes would continue on to IBU Cup Tour #2.

AMENDMENT: Matthew Hudec has been selected to WC#4 based on his single best result from IBU Tour #1.

*Should the same athlete earn selection to positions 1 and 2, position 2 will be selected according to the General Selection Method.

- 1. Most WC points scored following WC #6
- 2. Second most WC points scored following WC #6
- 3. Single-best placing on WC following WC #6
- 4. General Selection Method

Should the same athlete earn selection to more than one position, the General Selection Method will be applied to the open (either 2 or 3) position (s).

-A fifth male and female athlete *may* be selected for the World Championships based on the General Selection Method.

*World Cup #9: The team for WC #9 may be reduced at the discretion of the HPWG

Selection:

- -Two Senior Men and two Senior Women will be selected from in-season results from either the WC or IBU Cup tours
- -Based on discretionary selection by the HPWG, two Junior Men and two Junior Women from WJCH may be offered starts in the Kontiolahti and Otepaa, IBU Cups. (* Junior athletes accepting Kontiolahti and Otepaa positions will have an additional \$1000 trip fee).

Selection: Selection will be made by ranking the average performance percentage based on the three races at Junior Selection Trials January 7-9, 2017.

Junior athletes will race a common distance with Youth athletes but percentages will be based on their respective category.

AMENDMENT: Pearce Hanna is pre-selected to WJ Championships based on performance demonstrated on IBU Tour #1.

Trip A is comprised of pre-camp and WJ Championships

Trip B is comprised of pre-camp, WJ Championships and IBU Cup # 7, Kontiolahti, FIN and IBU Cup #8, Otepaa, EST (Two Junior Men and Two Junior Women *may* be nominated to Trip B)
